3. Foreign Companies in Egypt don't have the right to have An Import License based on Egyptian Law.

### Why you use IOR Service?

Critically an IOR does not normally take title to the goods, so they are only providing a service and do not have A financial Interest in the good so they Play any part in the Sale/purchase of goods. This is a vital point as it means that they act as an independent representative. As such the authorities should not treat them as an 'agent' of a seller, and thus there is reduced risk of corporate tax exposures.



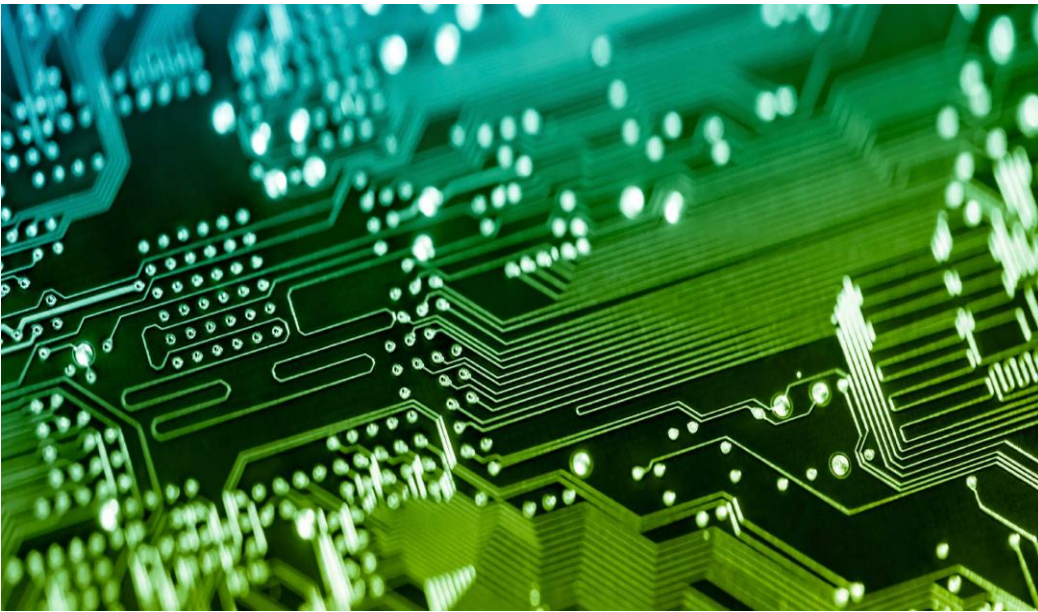
### What are the Services Provided by Nile Logistics IOR Service?

In essence most of the risks associated with assessments by the Customs / Tax authorities and the administration are borne by the IOR.

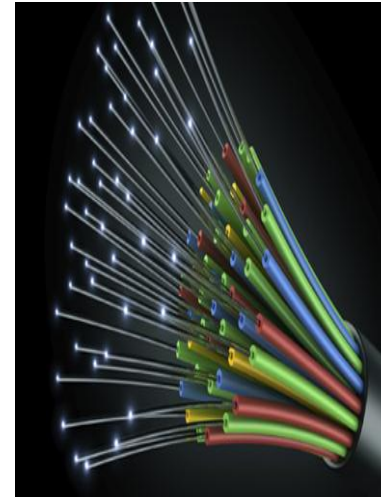
